Social Media

- Ethical concerns
 - Public/private accounts
 - No direct contact
 - No Facebook friending
 - No Instagram following
 - No Twitter following
 - No Snapchat friends
 - No TikTok following
 - Hire private investigators/outside vendor

Discovery

- Requesting information from employee
 - Interrogatories
 - RPDs
 - Depositions
- Requesting information from third parties
 - Third-party RPDs

Evidentiary Issues

- Hearing issues
 - How to use surveillance/investigative evidence at a hearing
 - Disclose to other side
 - If more than impeachment
 - 48 hours in advance prior to hearing
 - Waiver prior to hearing
 - Sending to doctors for opinion
 - Common objections
 - Hearsay
 - Defenses to the same
 - Authentication
 - Stipulations
 - Investigator testimony
 - Cross examination
